MuckBiotics

- Successful results were reported in treated areas, upon discussion feedback was positive
- The district would hope to see expansion in the buying by the bag purchases
- Discussion was held considering MuckBiotics treatment in several different, targeted areas financed by the Lake District and completed by the harvesting crew
- No targeted area was agreed upon as MuckBiotic treatment was tabled until the 2025 budget is finalized

- Other suggestions considered were; owners sampling soil before fertilizing, using less fertilizer on lawns
- Tracy Arnold offered information on soil sample bags and testing

Harvesting 2024 report and planning for 2025

The harvesting for 2024 went well except for a GPS unit issue. One unit was under warranty repair and was not returned until harvesting was completed for the summer. Questions arose asking if phones would serve the purpose better but Krista Olson and Jim Stanchik both spoke on the importance of painting on the maps and needing a larger visual. Ride alongs were encouraged for folks to see what harvesting entails.

- The new gas tank supply from FS in Wisconsin Rapids worked very well and a credit will be forwarded to the district
- Butch Filtz will overhaul the garbage truck this winter
- The district will ask the city to consider building a small storage shed at the harvester landing vs the present trailer, if not we may need to fundraise for a proper storage shed
- City Planning; the disc golf course will remain
- Mapping has been completed but not yet sent from TIGRIS
