#### **Feltz Land Trust Donation**

- Land will be donated to Lake District and held by Lake District to become public land
- Menominee tribe will be welcome to place markers and hold ceremony recognizing burial mounds
- Margarita Renteria moved to accept the donation. The motion was seconded by Joe Senn and approved by all lake district members present
- Krista Olson (President) and Casey Schoettmer (Secretary) signed the paperwork to accept the donation of the land
